# Safety Legislation

- AB 1747 (Rodriguez) changes related to school safety plans. The bill requires 1) first responder entities to be consulted with in the development of school safety plans; 2) school safety plans to be shared with law enforcement; and 3) the inclusion of procedures related to active shooters.
- SB 395 (Lara) Beginning January 1, 2018, minors under the age of 16 must consult with legal counsel prior to a custodial interrogation and before waiving their Miranda rights.

## Active Shooter Training

- This month active shooter training will begin with PG middle school staff and PGPD. Due to the ever rising threats of active shooters across the nation, PG Middle school will partake in a drill designed to test the ability and knowledge of school staff regarding active shooters.
- PGPD has started training on active shooter drills within our school district. On a separate date, PGPD officers will be evaluated on their ability to respond, coordinate support and their ability to implement our active shooter policy.

## Physical Security

- The year has already exposed a few issues of security concern regarding PG Middle School and PG High.
- Due to recent traffic collisions and crimes on campus we have identified some concerns that should be addressed. It is suggested the campuses begin the process of installing fences and updating cameras to help deter incidents and or crime.
- While reviewing several cameras it was found that many are either in a bad location or brush from trees is blocking the view.

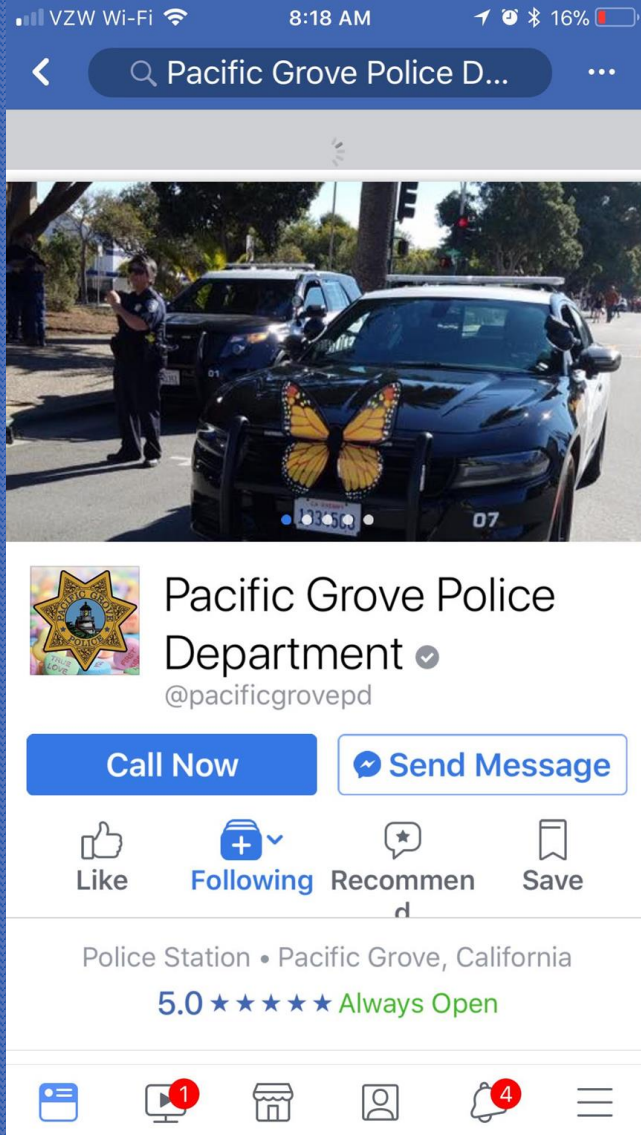

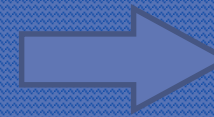
